3 Matters Arising:

Water Troughs

JM has reported that Bristol Water seems to have lost interest again, so the status quo has been maintained.

WT CEO visit

Went very well. Becky Speight was very interested and happy with everything.

4 Updates from Joe Middleton

Hedge cutting - JM had been over to look at the situation after the recent hedge cutting – resultant ruts etc – and was not concerned, except for the corner by the Rugby Club. Even so, he will instruct the contractor to do the work in October (when the ground should be drier/firmer) in future, when possible. He then sent an updated map through for approval, which will be correct once his southernmost marking has been moved to the true southern boundary.

Insurance

The WT no longer allows volunteers to use mechanical equipment on their land (since an incident with a chainsaw in Scotland). MC, a WT certified contractor, has public liability insurance, including 4 employees covered to accompany him. JC will check with JM if this would be allowed. An alternative would be for FHW to get its own insurance at, say, £100 p/a – JC to explore with ie NFU and RIAS

Yellow Rattle

JM will supply seed in August for FHW to sow, after scarifying. MC to explore a scarifier to tow behind his compact tractor, or will hire a hand machine again.

Removal of tree tubes

JM had suggested removing guards from the bigger trees, until HH and NH pointed out that deer had killed the unprotected oaks in the first year. In the end it was decided to experiment with a few, replacing the tubes with rabbit spirals, on the bigger willows near the gateway between F1 and F2, as the deer seem to prefer the more open spaces. Timing should be April/May when the main growth starts.
